As of December 31, 2025, Lynrock Lake Master Fund LP ("Lynrock Lake Master") directly held 1,154,586 shares of the Issuer's Common Stock. In addition, as of December 31, 2025, Lynrock Lake Master directly held warrants of the Issuer that are not presently exercisable into shares of the Issuer's Common Stock due to certain approximately 4.9% beneficial ownership limitations. Lynrock Lake LP (the "Investment Manager") is the investment manager of Lynrock Lake Master, and pursuant to an investment management agreement, the Investment Manager has been delegated full voting and investment power over securities of the Issuer held by Lynrock Lake Master. Cynthia Paul, the Chief Investment Officer of the Investment Manager and Sole Member of Lynrock Lake Partners LLC, the general partner of the Investment Manager, may be deemed to exercise voting and investment power over securities of the Issuer held by Lynrock Lake Master %

As of December 31, 2025, the Reporting Persons had sole power to vote or to direct the vote of 1,154,586 shares of Common Stock.
